philanthropic support; need for psychosocial support; demand for information, communication and education services. A number of recommendations were made regarding human resources, facilities, communication and supervision of social work service to better meet the needs of patients when examined and treated at the hospital, as well as methods to improve the quality of hospital services.

## **Mapping Levels of Metaphors about War in English Political News**

**Abstract:** The study aims to systematically investigate the conceptual mapping structure of war-related metaphors in English discourse on political issues taken from the news articles in official websites of some Western countries where English is the first language including the UK, the US, and Australia. The research methodology is mainly qualitative analysis, which is specified by techniques such as discourse analysis, description, and classification. Besides, statistical analysis was also applied

at some stages. As evidenced in the findings, war metaphor has a fairly rich conceptual mapping structure which represents the hierarchical conceptualisation of politics in English. Given the fact that the first level mapping is *Politics as war*, the research resulted in 3 derivative mappings, including: *Elements in political activities as elements in war*; *Political activities as military activities*; *Political results as war results*. On the basis of this mapping scheme, 8 third-level constituent mappings were

generated. In light of cognitive theories, as well as the knowledge of embodied experience, the data is a result of the analysis and generalisations of the cognitive correlations between war entities, actions, activities and characteristics and those in politics. It is hoped that the study will make positive contribution to linguistic study and

language education in general, and somewhat support those who are involved in language translation, journalistic writing and reporting about politics in particular.
