It is documented that about one third psychologists do not recognize well enough the importance of confidentiality during

comparison their practice. In to psychological practitioners, students generally show better understanding and acknowledgement of confidentiality principles. Similarly, psychologists who have never charged for their services are better aware of confidentiality principles than those who have.
