Messages About Korea on Nhan Dan and Tuoi Tre Newspapers in 25 Years After the Diplomatic Normalisation

Abstract: This article presents the research on messages about Korea in two Vietnamese major newspapers in the 25 years after the diplomatic normalization in 1992. Applying the Framing Theory and PEST model to analyze and explain the content of Korea related articles, the study generalizes the change in the messages about Korea in Vietnamese newspapers over the past quarter of a century. The research results indicate that there has been a significant increase in the frequency of such articles after each year in accordance with the development in Korean-Vietnamese bilateral relations. Furthermore, political content, namely the tension between North and South Korea has been reflected with the greatest number of articles. Despite being the number one FDI investor in Vietnam and having a high level of development in science and technology, the articles about economic, science and technology sectors only account for a small proportion. This can be regarded as that the Korean government still does not have an effective strategy to reinforce the Korean national image in Vietnam as through the past 25 years.

The Role of Women in Use of Social Capital to Raise Financial Capital for Production in the Traditional Villages of the Red River Delta

Abstract: Financial capital and social capital are two types of capital needed in production in general and handicraft production in particular. In many cases, these two types of capital can be partially transformed by each other. This article discusses how women use social capital to raise financial capital for maintaining and developing handicraft production. The paper is based on the results of questionnaires and in-depth interviews of women who are household heads or co-owners in two handicraft villages of Thuong Tin district of Hanoi such as Ha Thai (lacquer village) and Trat Cau (blankets, bedsheets, pillows, mattress village). The results show that

women are promoting their roles not only in the production process but also in borrowing financial capital through the use of social capital from the family network to external networks such as formal organizations and voluntary and informal groups. In particular, the support of family networks and relatives is the most important one. By having mutual trust in relationships, borrowing from these networks brings many benefits such as lowinterest rates. no collateral. simple transactions, reduced costs and time for borrowers. External family networks such as socio-political organizations or voluntary groups have not shown the role of supporting loans for women in two craft villages.
