Abstract: Luo Yue (or Lac Việt in Vietnamese) is a widely used ethnonym both in Chinese and Vietnamese scientific literature. By the end of the 20th century, notwithstanding the thorough study of Luo Yue history, mythology, linguistics and culture, the origin of the Luo Yue people is still debated. In order to solve this problem, we need to update or upgrade our old theories and methodologies in light of rapidly developing sciences. My proposed research plan will consider the Luo Yue ethnonym from a double perspective: as an exonym that Han Chinese used to refer to a community in southern China more than two thousand years ago and as an autonym of the Viet people since independence in the last thousand years. Luo Yue as an exonym is to be looked for in a large area in historical

China and Vietnam while Luo Yue as an autonym is to be considered as a result of nationalization the process of and symbolization of the original medieval Viet people. In this double perspective, contradistincting the two ethnonyms and at the same time considering them in their interdependence, my research will try to throw new light on the meaning of the Luo Yue relying on new theories of James Scott (Zomia) and Anthony Smith (ethnosymbolism) in order to understand the ethnicity of the Viet people. Furthermore, I would like to give an overview of the Luo Yue from the molecular anthropology in this research.

Tay Son Nhat (An Khe) Hamlet Through the Land Records

Abstract: Tay Son Nhat (An Khe) hamlet was the first homeland of the Tay Son brothers in Dang Trong. This hamlet, which belonged to the Upper Tay Son region, was the place where Nguyen Nhac chose to build a base, establishing the first camp of Tay Son insurgents. The land records of Tay Son Nhat hamlet (established

in 1805) and of An Khe hamlet (established in 1865) provided very specific data on each type of public and private land. The analysis of these records shows the variation in ownership types as well as land distribution in An Khe in the first half of the nineteenth century, after the Tay Son failed. The fragmented nature of land here, especially

the cultivated land, is partially explained by its geographical location with mountainous terrain. But more importantly, the fragmentation in the private land of An Khe should be further considered from the effects of Minh Menh's 1839 land reform policy implemented only in Binh Dinh province. The profound purpose of this

policy, in our opinion, was the revenge of the Nguyen, to eradicate the achievements of the land that the Tay Son movement had brought to people in Binh Dinh province in general, and An Khe hamlet in particular!

"Rewriting of the Old Editions": On the Origins of the Romanized Versions of the Mulian Story in Vietnam during the First Half of the XX Century

Abstract: The Mulian story transmitted to Vietnam from China around the 10th century, and initially was associated with the Buddhist rituals on the fifteenth day of the seventh lunar month. The story of Mulian, like many other Buddhist stories, was adapted into Vietnamese narrative verse with the six-eight (luc-bát) syllable meter. It represented vernacular literature written with the Nôm script and was circulated in Vietnam in the form of manuscripts and woodblock printed editions from the seventeenth to the nineteenth century. In the first half of the twentieth century, along with the spread of romanized Vietnamese script (Quốc ngữ) and the development of modern printing technology, publishers in two major printing centers of Vietnam - Hanoi and Saigon - printed several versions of Mulian story in romanized script. While several editions were clearly indicated to be newly composed works, most of these new editions were claimed to be translations of the Nôm versions. Inspired by the theories of literature translation comparative and studies approaches, this paper argues that all these romanized versions were not the exact transcriptions of any Nôm version.
