Contributing to the Study of Lord Trinh Kiem's Family through the Stele "Dai Vuong Tan Mieu Ky" and Related Documents

Abstract: The historical figure Trinh Kiem (1503 - 1570) and members of his family remain insufficiently explored in

Vietnamese historiography, with notable inconsistencies among existing studies. The epigraphic corpus from the Revival Le

period (Le Trung Hung) in Thanh Hoa particularly the stele "Dai Vuong tan mieu ky" - constitutes a highly credible historical source that helps address these gaps. Based on a critical examination of Vuong mieu ky and the Dai tan comparative analysis relevant documents, this article contributes to clarifying biographical details about certain members of Lord Trinh Kiem's family. It also corrects several inaccuracies found in Le Quy Don's "Dai Viet thong su" regarding key individuals and the Le Cong lineage - a distinguished founding family of the Binh Ngo resistance from the "huong Lam Son" (Thanh Hoa) during the fifteenth and sixteenth centuries.

Sources of Funding for Ritual Offerings in Ceremonial Activities from the 19th Century to Before the August Revolution of 1945: The Case of the Blessing - Prayer Ceremony in Ha Dong Province

Abstract: **Before** the August Revolution, Vietnamese villages were relatively self-sufficient, tightly connected communities, where communal worship was among the most widespread activities due to a dense ceremonial calendar. Consequently, expenditures for offerings became one of the largest forms of communal spending. This examines funding sources for offerings during the Cau phuc (Blessing-Prayer) Ceremony in Ha Dong Province, identifying two primary funding sources. The collective source is represented by

 $gi\acute{a}p$ and communal lands, and the individual source is represented by $ch\acute{v}c$ $s\acute{a}c$ and lềnh. The study concludes that villages typically relied on a single primary funding source for offerings, with individual contributions often being of lower value than collective ones. Within collective funding, $gi\acute{a}p$ leaders bore primary responsibility, while in individual funding, the $l\grave{e}nh$ played the main role.

Research Ethics in Higher Education Institutions: Challenges and Implementation Strategies in the Social Sciences and Humanities

Abstract: This article emphasizes the significance of research ethics in higher

education institutions, particularly within the disciplines of the social sciences and humanities. The paper analyzes key challenges in establishing and operating ethics review boards or ethics committees, developing institutional research ethics codes, and addressing limited awareness of research ethics among faculty members, researchers, and students. The paper also highlights the practical difficulties of applying ethical standards in the context of transformation. In strategies for integrating research ethics into training programs are discussed. The University of Social Sciences Humanities, Vietnam National University Ho Chi Minh City is selected as a case study to examine both the advantages and constraints in organizing and operating a research ethics review board. Alongside secondary data from various sources, the study also draws on primary data collected from ten semi-structured interviews conducted in January 2025 with key stakeholders, including graduate students, faculty members, faculty graduate coordinators, and faculty managers. Based on the findings, the article proposes several measures to enhance the effectiveness and quality of ethics review boards in higher education.

Understanding Ecosystem Service Awareness at the Community Level: The Case of the Buffer Zone of Song Thanh National Park and Cu Lao Cham Biosphere Reserve

Abstract: The awareness and approach to ecosystem services among local people in the buffer zones of national parks and conservation areas around the world is often limited, which significantly impacts conservation efforts and sustainable development. The Song Thanh National Park (STNP) and Cu Lao Cham Biosphere Reserve (CLCBR) are no exception. This employs a knowledge-attitudepractice (KAP) approach to construct interview questions. A total of 15 in-depth interviews, 6 focus group discussions, and 300 households were surveyed in STNP, CLCBR, and Cam Thanh Mangrove Forest. The results indicate that provisioning services are utilized more

than other services, particularly freshwater supply, followed by regulating services such as air filtration and microclimate regulation, which are considered the most important. Furthermore, the emphasizes that integrating ecosystem services into policy-making processes can help achieve various objectives, such as enhancing biodiversity, reducing poverty, improving health, and adapting to climate change. It can also support implementation of international agreements, such as the Sustainable Development Goals, the Convention on Biological Diversity, and the Agreement. By recognizing and assessing the contributions of ecosystem services, policymakers can make more balanced and informed choices, clarifying trade-offs and synergies among sectors and other stakeholders.

Stories), we argue that Nguyen Ngoc Tu has shown a shift from slow violence to ecological ambiguity through depictions of identity crises and ecological transformation. Additionally, the author conveys her perspective on the land and people of the Southern region while raising questions about the darker aspects of environmental protection discourse.

Common Mistakes When Using Honorifics in Korean Language by Students Majoring in Korean Studies, Faculty of Oriental Studies, Van Hien University

Abstract: This study analyzes errors in using Korean honorifics among 100 thirdand fourth-year Korean Studies students, Department of East Asian Studies, Van Hien University, to enhance understanding of honorific rules and principles. Through a survey, two main error types were identified: (1) Lexical errors: (2) Grammatical errors. Causes include differences typological between Vietnamese and Korean, lack of practice in real-life contexts, and difficulties in mastering the lexical and grammatical aspects of Korean honorifics. Proposed solutions involve increasing contextual practice and learning from native speakers, thereby contributing to developing teaching materials to improve honorific usage skills for Vietnamese students.

Self-Presentation on Social Media among Undergraduate Students at the University of Social Sciences and Humanities, Vietnam National University, Hanoi

Abstrac: Entering the era of Industry 4.0, social media has become a vital space for adolescents, particularly university This study investigates how students. students at the University of Social Humanities, Sciences and Vietnam University, **National** Hanoi present themselves on social media through three self-expression, dimensions: disclosure, and the construction of a professional image. It also analyzes the relationship between the quality of peer

relationships and online self-presentation. Based on a survey sample of 275 students, the findings indicate that most students use social media frequently, tend to present themselves honestly, and do not overly prioritize virtual spaces. Students selectively disclose personal information, focusing mainly on academic matters and interpersonal relationships, while sharing less about economic or social issues. Although students demonstrate a relatively high awareness of building a professional

online image, those with close-knit friendships tend to invest less in developing professional networks online. This reflects an emotional inclination in students' social behaviors. The study suggests that guiding students to use social media strategically with a balanced

emphasis on personal relationships and professional development is essential to support their personal growth and integration in the virtual environment.
