Abstract: With the orientation of researching, preserving and promoting the beautiful traditional cultural values of the nation, based on written and real-life materials, the article provides some basic knowledge about the system of traditional altarpieces in Vietnamese worship halls with about 40 types of altarpieces distributed according to the structure of the northern traditional worship space. The paper uses fieldwork. methods of statistics, classification, synthesis, general analysis, combining the use of cultural methods, cultural anthropology, religious anthropology and interdisciplinary research to explain the continuity of altarpieces,

which is represented through materials, decorative plans, patterns, changes in display position, function and scope of use. The article argues that rituals and customs of worship in general and altarpieces in "unchangeable particular are not an oneness". Depending on the time custom, the customs are more or less modified. Change and creativity acceptable but it should be based on the basis of knowledge, correct and thorough understanding of traditional culture and rituals.
