Vietnamese - Cambodian Cooperation in Combatting Crimes at the Mutual Border

Abstract: In recent years, the Vietnamese - Cambodian border has seen increased activities of all kinds of crimes, especially illegal trading, trafficking of narcotics, and human trafficking. Criminals of both countries have been trying to link up with each other and other nationals, forming networks transnational criminal and organizations. This problem becomes a nontraditional security threat, directly affecting the interests and national security of Vietnam and Cambodia. Identifying risks and challenges from these crimes, both counties have signed cooperation plans and creating mechanisms programs, for competent authorities to strengthen their efforts in combatting crimes at the border since 2009. The results show that, in the past 10 years, cooperation between the two countries in this field has achieved some important results, but some limitations need to be coordinated. Cultural Heritage in the Global Hierarchy of Value Through the Perspective of Michael Herzfeld

Abstract: In his presentation "Cultural Heritage for the Future: UNESCO's 2003 Convention for the Safeguarding of the Intangible Cultural Heritage", former UNESCO expert Frank Proschan said that UNESCO did not acknowledge reality when it conferred the title of intangible cultural

heritage on particular traditions or practices. In addition, the use of the word "công nhận" in Vietnamese to translate the concept of national intangible cultural heritage does not represent a true understanding of the spirit of the 2003 Convention. This article explores the phenomenon of the distorting

effects of licensing cultural heritage and shows that these do not only exist in Vietnam. We also find them vibrantly represented in the last century in Greece as described in the remarkable study "The body impolitic: Artisans and artifice in the global hierarchy of value" by Michael Herzfeld from Harvard University. This is an important study that shows that items displayed as traditional Greek heritage are not merely exhibits but, in that role, distort the reality of the life of the artisans who create them. Herzfeld thereby criticizes the stereotypical presentation of artifacts from

their social and cultural context and artificially places artisans on the island of Crete in a "global hierarchy of value" that ranks them as culturally inferior while also praising them as relics of a glorious past. His observations provide us an insight into the impacts of globalization on the heritage industry as well as on social life in Greece and can thereby illuminate the current situation of Vietnam.

Imprints of Confucianism, Taoism, and Buddhism in the Poetry of Women in the Tang - Five Dynasties Period

Abstract: By analyzing poetry written by women during the Tang - Five Dynasties period, this article points out the imprints of three important ideologies in Chinese culture (Confucianism, Taoism, Buddhism). Among these, Confucianism has the deepest imprint expressed through the consciousness of women about their roles in the family. Taoist imprints are also a noteworthy point in the poetry of women in Tang - Five Dynasties period, whose most concentrated expression are the poems writing about the daily lives of the female Taoists. In addition, it is also expressed through the devotion in the poetry by some royal women as well as in the rich imaginings related to the fairy in the poetry by women in various social classes. In contrast, the imprint of Buddhism is relatively faint and mostly associated with depiction of the activities such as visiting pagodas, listening to Buddhist scriptures, and using Zen jargon in some poems by a few authors.

The Role and Meaning of the Questioning Element in Rhetorical Questions

Abstract: This paper proves the existence of interrogative meaning in rhetorical questions, from the broadest perspective, which is not different from ordinary questions. However, the mechanism of formation and the role of this element in the rhetorical question have distinct characteristics. The starting point for this study are the views of linguists so far, often regard the presence questioning elements in rhetorical questions purely as a form without content, meaning they are interrogative in form but are not used for asking. New data is presented to

show that the presence of interrogative elements in rhetorical questions is justified. These elements have certain values, contributing to the specific semantic features of this type of sentence; they are even an important component that contributes to a question-refute communication strategy, an outstanding pragmatic function of rhetorical questions.
