Livelihoods of coastal households in the context of climate change and extreme weather events (Case study in Phu Dien commune, Phu Vang district, Thua Thien Hue province)

Abstract: This paper aims at examining the difficulties and modifications traditional livelihoods of local fishing households in Phu Dien coastal commune, Phu Vang district, Thua Thien Hue province in the context of climate change and severe hazards. applied We qualitative and quantitative methods in data collection and analysis. The findings revealed that local climate variables and natural hazards have noticeably changed towards the severity and unpredictability, which negatively affects traditional fishing livelihoods of coastal households such as fishing, fish trading and fish-sauce making. In order to sustain livelihoods and ensure

household income, local households developed and implemented a wide range of modifications including flexible investment in traditional fishing and/or diversification toward non-fishing activities with a major focus on seasonal labor work. Although it was evident that local government provided some institutional supports to local fishing households, the paper suggests that local government needs to create a more supportive environment for local fishing households to sustainably and effectively cope with climate change.

Abstract: Gaston Bachelard (1884-1962) was one of France's most famous philosophers in the first half of the 20th century. Epistemology is an important aspect of Bachelard's colorful philosophical heritage and has profoundly influenced great thinkers like Georges Canguilhem, Michel Foucault, Pierre Bourdieu, and others. In his

epistemological writings, Bachelard has come up with novel ideas about new scientific development. He addressed important metaphysical subjects such as the philosophy of time and new concepts such phenomenotechnique (phénoas ménotechique), Rhythmman (rhythmanalyse), the breaking of epistemology (rupture pressistémologique) or Obstacles to epistemology (obstacle épistémologique). In this article, the author focuses on Gaston Bachelard's conception of primary experience obstacles, including (i.) his natural scientific premise of epistemology; (ii.) primary experience – an

obstacle to the formation of the scientific spirit; (iii.) the pedagogical consequences of primary experience obstacles; and (iv.) a few reviews.

Factors Affecting The Quality of The Sinh Village Wrestling Festival in Phu Mau, Phu Vang, Thua Thien Hue

Abstract: The quality of festivals is one of the important factors determining the attractiveness of a destination and tourists' intention to revisit the place, creating a premise for the local festival tourism activities to develop according to their potential. This study aims to evaluate the quality of the Sinh Village wrestling festival and determine the factors that influence the quality of festival through the survey of 150 guests attending the festival. The methods used in the study includes analysis of Cronbach's Alpha reliability, Exploratory Factor Analysis and multiple regression analysis. The research results revealed that the quality of the festival is influenced by five factors: (i) facilities and amenities, (ii) environment, (iii) supplementary services, (iv) program, and (v) organizers and staff. Basing on the result, the authors propose a number of measures to improve the quality of the Sinh Village wrestling festival, which contributes to the development of folk festival tourism in the future.

Using Image Schemata to Teach Spatial Meanings of English Prepositions: Experimental Results and Vietnamese EFL Students' Opinions from a Pilot Study

Abstract: This quasi-experimental study aims to apply basic concepts in cognitive linguistics to teaching spatial meanings of English prepositions to Vietnamese students. Different from previous research, this study extended the application to teaching the ten prepositions above, among, at, behind, beside, between, in, in front of, on, and and investigated the students' under, opinions. The teacher used 3D image schemata, integrated picture-language models, productive tasks after and

instruction to investigate the effects of the pedagogical methods. Extraneous variables were also explored to measure the research validity and reliability. The results revealed that the experimental group outperformed the group who were taught in the traditional method. The students also expressed positive opinions about the methodology based on cognitive linguistics.
